- Senate/Assembly Split on Major Education Issues Worked to Our Advantage
- Race for Governor Walker vs. Burke; What's the Outlook?
- Lots of Legislative Retirements
- Schultz, Ellis and Kestell Decline to Run; A Great Loss for Public Education

2013-14 Legislative Session – Major Issues

- Given the Environment, What We Accomplished was Incredible
- Common Core SB 619; SAA Strongly Opposed; March 6 Senate Ed. Hearing
- School Accountability Governor Signed "Slimmed-Down" SB 286; SAA Support
- Charter School Expansion SAA Helped Kill SB 76 and AB 549
- Special Needs Vouchers SB 525; SAA Opposed
- Special Ed Subs SB 271, Aid for Private Contracting, Governor Signed
- Remove 180-day Requirement SB 589; Governor Signed
- Fund 80 SB 478; Governor Signed; SAA Made Bill Better

- Course Options Law
- Leg Council Studies on SAGE, WTCS, TIF Districts
- School Fund Balance

What Did We Do Well? How?

- More SAA Members in Active Communication with Legislators than Ever Before
- Our Rural, Senate GOP Strategy Worked Better Than I Could Have Imagined
- The Signature Event March 6th Press Conference and Public Hearing on SB 619
- Showed GOP Majority We Can Deliver
- Showed Our Firewall We Will Support Them
- Showed SAA Members the Impact We Can Have Even in Difficult Environment
- After March 6th, "Bad" K-12 Legislation Got No Traction

Preparing for Next Session

- Recognize the New Political Reality
- WEAC is Essentially Gone Voucher Proponents the New 800-lb. Gorilla
- Democrats Can't Help Us Much Right Now
- Dependent on a Handful of Moderate GOP Senators Our Firewall
- 2014 Elections: Environment Will Likely Get Worse Next Session
- More Leadership Expected of SAA We Cannot Stand Pat as Political Organization

- We Must Expand K-12 Advocates' Capacity to Influence Public Policy
- We Have Little Time to Lose!!!

- SAA Members Must Build Stronger Relationships With Their Legislators

- Collaborations/Partnerships With Groups Who Share SAA Principles/Objectives
- Create and Promote a Compelling Vision <u>for</u> Public Education
- Consistent, Positive Messaging About the Value and Effectiveness of Public Schools

- We Lack Research-Based Education Policy Expertise As Well
- SAA Already Has Solutions in Place for Both of These Needs
