Description:

LLI is a small group intervention for children in Grades K– 6, who find reading and writing difficult to learn. The children selected for the interventions are the lowest achievers in literacy in their grade level and are not receiving another intervention. You will receive a schedule indicating which LLI and assessment materials are required for participants to bring to each class. Training materials will be available through Heinemann. These materials are not part of the registration fee. Supplemental materials, developed by the CESA 6 Literacy Center to enhance the delivery and monitoring of the intervention system, are included in the fee of the workshop.

LLI Grades 3-6 Building Upon LLI K-2 System:

- Difference between the two systems
- Data systems and assessment procedures for selection, discontinuing, and monitoring progress and sustained gains
- Weaving the teacher support tools with the lesson guides to meet for each group's specific need
- Matching teacher language and lesson activities to capitalize on an asset (rather than deficit) model to move students through gradients of knowledge and behaviors towards proficiency

This workshop is a training in the Intermediate Systems—LLI for Grade 3 (Levels L-Q/Red) and Grade 4 (Levels O-T/Gold).

Workshop Objectives:

To support teachers, administrators, and schools to realize the following potential impact of LLI for Grades 3-6.

- Accelerate the lowest performing readers to be achieving at grade level by the end of one school year.
- Significantly reduce the Learning Disabilities population due to reading difficulties.
- Qualitatively raise the profile of your bottom quartile readers.
- Enhance the rigor of classroom literacy instruction.

Who should attend: For teachers already trained LLI K-2 and teach students reading at the third-sixth grade reading level (Fountas and Pinnell text levels L-T)
