LLI is a small group intervention for children in Grades K– 6, who find reading and writing difficult to learn. The children selected for the interventions are the lowest achievers in literacy in their grade level and are not receiving another intervention. Supplemental materials, developed by the CESA 6 Literacy Center, to enhance the delivery and monitoring of the intervention system, are included in the fee of the workshop.

This workshop is a training in the Intermediate Systems—LLI for Grade 3 (Levels L-Q/Red) and Grade 4 (Levels O-T/Gold).

- Accelerate the lowest performing readers to be achieving at grade level by the end of one school year.
- Significantly reduce the Learning Disabilities population due to reading difficulties.
- Qualitatively raise the profile of your bottom quartile readers.
- Enhance the rigor of classroom literacy instruction.

For teachers using the Red or Gold LLI Systems, and teach students reading at the third-sixth grade reading level (Fountas and Pinnell text levels L-T)
