## Description

Comprehension Focus Groups (CFG) are designed for students in fourth through secondary level grades who need to learn how to consistently use knowledge of text genres and text structures in order to **read** for a specific purpose and to use appropriate strategies to construct meaning. Additionally, CFG is designed to help students consistently use knowledge of text genre and text structures in order to **write** for a specific purpose and to use strategies to convey an appropriate message. This 4-session training will also focus on alignment of the CFG intervention to classroom instruction and the Common Core State Standards. Come learn how this intervention, as one of several interventions in the Comprehensive Intervention Model's (CIM) multi-level system of support, meets the principles for RtI in Wisconsin! (Note: learning from each session will build on the previous session.)



## Workshop Objectives:

Participants will learn about:

- Predictable routines
- Precision prompting for higher order thinking
- How to choose mentor texts
- How to align the intervention with classroom instruction
- How to plan for reading and writing
- How to incorporate on-going assessment and end of unit progress monitoring
- How to plan with the Common Core State Standards

- Several sample lesson plans
- Two professional texts: *Interventions That Work* and *Teaching for Deep Comprehension*
