She has attended workshops at the TLC Institute for the past four summers and is currently working on her Level 3 Trauma Supervisor, as well as Trauma Assessment Consultant certification. Through the use of Sensory Integrated Techniques for Children and Adolescents, students on her caseload have increased school performance, and decreased PTSD symptoms, school absences and office discipline referrals. Julie will share the concepts behind this technique and interventions that can be used in classrooms, groups and individually with children of trauma.
