## **Description**

The purpose of a literacy intervention, whether it be in elementary, middle, or high school, is too accelerate learning in order to position the student to no



longer need intervening services beyond core instruction. How can literacy interventions be aligned to core instruction? What are the necessary considerations for designing literacy interventions that align to core instruction? How can evidence based and researched based teaching strategies supported by an RtI framework be used to accelerate learning? What theoretical understandings are necessary for the literacy interventionist to have under control in order to teach for acceleration at the elementary, middle, and high school levels? What do Tier 2 and Tier 3 literacy interventions look like in an aligned RtI system? How can this be done without buying programs? This half day workshop will provide answers to these questions.
