

Preparing CTE for 2014-15

As the 2014-15 school year rapidly approaches, there are many expectations that our Career and Technical Educators need to meet. Together at CESA, we are preparing a series of trainings for this group to help prepare them for this academic year. During this academic year, educators will be expected to write student learner objectives as part of the new evaluation system. For a CTE teacher to write an accurate SLO, they need to have data gathered from high quality assessments. High quality assessments are built from a solid standards based curriculum which is where we want to start!

SCHEDULE

Day 1: January 14, 2014

"Disciplinary Literacy and CTE Standards"

Spend the morning focusing on the implementation of disciplinary literacy standards in CTE courses and the afternoon focusing on the implementation of NEW! CTE standards.

Day 2: February 11, 2014

"Curriculum Audit"

Gather with regional colleagues to finish mapping the CCSS and CTE standards throughout your courses. Follow an auditing process to determine if your curriculum maps are aligned.

Day 3: March 19, 2014

"Assessment Development"

With standard based curriculum maps in our hands, educators will begin developing standard based assessments that will help them gather data for progress monitoring and the SLO's.

Day 4: August 6, 2014 (tentative date)

"CTE and SLO's"

Learn about the NEW! Evaluation system for educators, analyze your data to determine school/district need, and prepare yourself for writing SLO's.

Day 5: August 7, 2014 (tentative date)

"Writing SLO's"

See samples of SLO's and write your own in preparation for the October 31st deadline portion of Educator Effectiveness.

Day 6: January 8, 2015

"Checking Progress"

Gather to discuss curriculum, assessments, and Educator Effectiveness progress.
