## Asbestos O&M REFRESHER Training

This mandatory training is required to meet the OSHA asbestos regulations adopted by Wisconsin Department of Safety and Professional Services. If you or your staff perform operations and maintenance activities at your facility, this training must be taken on an annual basis.

### Registration Cost

Cost for this training is \$150 per person. However, if your district currently has an Environmental Health and Safety contract with CESA 10, attendees will receive a \$25 discount for a total cost of \$125 per person. Lunch and snacks are included with the registration fee.
