WI Special Education Mediation System's Dispute Resolution Options

Description:

It is important for parents and school staff to resolve any issues right away – before these issues fester and negatively impact that all important home/school relationship.

This presentation will provide information on the WI Special Education Mediation System (WSEMS) and how it can assist with early dispute resolution. The presentation includes information about services for mediation, facilitated IEPs, and facilitated resolution meetings available through the WSEMS. These services are provided at no charge to parents and schools. The presentation will also cover areas such as: when to use each option; how to make a request; who are the mediators and facilitators as well as related federal and state laws; and more.

Participants will learn when and how to request mediation services through the WSEMS.
