Catch Them Early...Watch Them Grow!



This one day training provides an administrative overview of the system structures and commitments needed for effective implementation of Tier 2/3 of school-wide PBIS, including a description of the Tier 2/3 practices, data tools and fidelity measures.

The workshop is designed to assist administrators and leaders in preparing their staff for advanced training and implementation of secondary and tertiary systems. Emphasis is on the continuum of support across a three-tiered system, highlighting data tools and behavioral interventions for groups of students and individuals who require more than universal interventions to succeed.

District and school-level leaders need to have a complete understanding of what the PBIS Tier 2 and Tier 3 systems, data and practices entail so they can provide the necessary guidance to school staff as they move through Tier 2 and Tier 3 training and implementation. Repositioning of personnel to coach and facilitate specific PBIS Tier 2 and Tier 3 components become necessary. Administrators must be aware of needed roles/functions for Tier 2/3 implementation so they can anticipate and plan accordingly.

Presenter:

Lucille Eber, Ed.D.–Lucille is the State Director of the Illinois Positive Behavioral Interventions and Supports (PBIS) Network. Dr. Eber coordinates technical assistance and evaluation related to school-wide PBIS in over 900 IL schools. Dr. Eber also facilitates PBIS implementation and training plans for states and school districts across the country including Wisconsin. She regularly publishes articles and chapters on wraparound, interagency systems of care and school-wide positive behavior supports.
